

2022 FUNDED PROGRAMS

Brooke USA made contributions to an array of programs across the globe, as well as right here in the United States.



ADVOCACY FUND

Efforts continued to ensure a national ban on the import and sale of ejiao, the product derived from boiling donkey hides and used in traditional Chinese medicine. Before the end of the 117th Congress, the Ejiao Act was developed by sponsor Rep. Don Beyer (D–VA), setting the tone for future Congressional support during the newly elected 118th Congress now in session.

AFRICA FUND

Brooke West Africa (Senegal & Burkina Faso)

Disaster preparedness initiative to increase drought resilience for equine owning communities by promoting fodder production and providing means to ensure livestock feeding.

Brooke Ethiopia

Construction of health posts in two administrative districts to improve equine health and welfare through access to veterinary services as well as clean drinking water and shaded areas for respite.

AMERICAS FUND

Brooke Latin American & Caribbean [Nicaraqua]

Purchase of 60 sample plots for rural communities to learn how to cultivate crops and fodder and thus, provide nutritious food for both humans and their animals.

Horses & Humans Research Foundation (HHRF) [Chagrin Falls, OH] Partnership tasked with determining the welfare needs of working equines living on Native American reservations across the country. The result will be a body of knowledge intended to better serve these working animals.

Native American Horse Education Foundation (NAHEF) [Tucson, AZ] Provision of horseshoeing certifications to six members of the San Carlos Apache Indian Reservation in San Carlos, AZ. NAHEF provides students with the tools, skills, and knowledge to provide hoof care for their community's equines.

ASIA FUND

Brooke Pakistan

Immediate response to the catastrophic floods by providing relief through field teams and mobile units which ensured access to food and fodder as well as treatment to injured and sick animals. Delivery of food rations to both humans and animals.

Brooke India

Installation of equine first aid kits, water facilities, ventilated sheds and rolling pits for working equines. Training of equine owners and local animal health service providers on husbandry and healthcare, including improved harnessing materials and cart design, as well as nutrition and handling.

DISASTER & EMERGENCY FUND

The Board of Directors, from time to time, grants funds to geographic areas where disaster has made life difficult for equines and their owners.

In 2022, in addition to our support of Brooke Pakistan after the floods, Brooke USA donated funds to the United States Equestrian Federation's (USEF) Ukraine Relief Fund which supported equestrians and their horses who either remained in that nation and faced hardships or who were displaced due to the war.

Moreover, after Hurricane Ian devastated the southwest coast of Florida, Brooke USA supported rescue efforts in that area with emergency micro-grants to:




